

NOTE ON CADRE RESTRUCTURING PROPOSAL OF GROUP B & C CADRES/POSTS OF SURVEY OF INDIA

A board of the officers under the chairmanship of Major General Manoj Tayal, the then Addl. Surveyor General Central Zone, Jabalpur had prepared a draft Cadre Restructuring Proposal. Later, a committee was constituted vide this office letter No. W-13005/709- Cadre Restructuring dated 21-09-2010 to examine the said proposal.

The Committee forwarded the said draft restructuring proposal to all the service Associations of Survey of India vide this office letter No. J-12739/1436-Joint dt. 14-09-2010 and requested to submit their valuable comments/suggestion for consideration. All the service Associations of Survey of India submitted their comments/suggestions.

In continuation of above all the service Associations of Survey of India were invited by the said committee for their views and consultations on the Cadre Restructuring Proposal from 08-10-2010 to 27-10-2010 vide this office letter No. W-13296/709-Cadre Restructuring dt. 30-09-2010. All the service Associations of Survey of India presented their views/suggestions before the Committee of Cadre Restructuring during above said period. After the consultations with associations, the committee submitted a modified proposal to the Surveyor General of India.

Further, to discuss the proposal submitted by the committee, all Service Associations' representatives were invited on 03-03-2011 to Surveyor General's Office Dehradun and detailed discussions were held.

After consultations with the Associations and finalization of the proposal, the Restructuring Proposal was sent to DST for further necessary action vide this office letter No. W-5167/709-Cadre Restructuring dt. 10-07-2013 in accordance with the Department's letter No. SM/11/03/2011 dt. 17-04-2013 and D.O. No. SM/11/03/2011 dt. 22-05-2013.

The above Cadre Restructuring Proposal was revised as per the observation given by DST and re-submitted to DST in 2015-16.

In view of infusion of new Technologies, users' demands and the functional requirement of the Department, the Restructuring proposal was slightly modified by a new Committee and was resubmitted to DST vide this office letter No. W-2527/709-Cadre Restructuring dt. 04-07-2018.

In the modified Cadre Restructuring Proposal the basic cadre restructuring has been kept almost similar to that proposed during 2011-15. However, some minor modifications were carried out keeping in mind latest Technological scenario.
