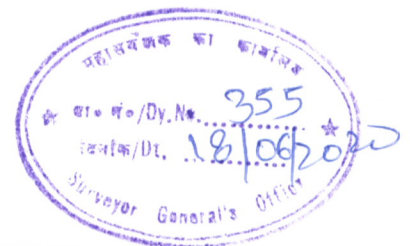

**SUB: REIMBURSEMENT IN RESPECT OF NEWSPAPERS PURCHASED/
SUPPLIED TO OFFICERS AT THEIR RESIDENCE--GUIDELINES--REG.**

REF: Your Letter No. SM/34/20/2019 dated 14.05.2019.

With reference to your letter under reference above, the following points are submitted for your kind perusal and necessary action :-

2. This office is following the guidelines issued by Government of India, Department of Expenditure's O.M. No. F.11(24)-E.II(A)/96 dated 13.09.1996 for reimbursement of Newspapers purchased/supplied to officers at their residence (copy of the same is attached for your perusal please).
3. In terms of Ministry of Finance (Deptt. of Expenditure)'s above O.M. and with the concurrence of Ministry of Science and Technology, New Delhi, vide their Letter No. F. No. SM/34-058-95 dated 19.07.2002, approval of the Surveyor General of India was conveyed to all GDCs for the re-imbursement of cost in respect of Indian News Papers to Officers in Survey of India at their residence with effect from 1.4.2002 as per scale, entitlement upto the Gazetted Group 'B' level, as has been stipulated in the aforesaid O.M. vide S.G.'s Letter No. 8593/644 dated 23.08.2002 (Copy enclosed for your perusal, please).
4. The pay scales of all the Group B Gazetted Officers of this Department during Vth CPC period was 6500-200-10500 (Officer Surveyor, C.Ds., ASO, etc) & 7450-225-11500 (E&AO), which was equal or more than the pay scales of Section Officers who were in the pay scale of 6500-200-10500 during that time.
5. After the implementation of VIth Central pay Commission, the Level/Grade pay of Section Officers varied from Department to Department (Rs. 4600/- to 5400/-). For example, the Grade pay of Section Officers in Ministry of Home Affairs, Ministry of Communications & IT and in National Commission for Minority Educational Institutions was Rs. 4600/- (Level 7) however in Ministry of Electronics & I.T. (UIDAI) and Central Secretariat it was Rs. 4800/- (Level 8) and in Ministry of External Affairs it is shown as Rs. 5400/-(Level 9). (copies enclosed for your ready reference).



6. Establishment & Accounts Officer in Survey of India is Group 'B' Gazetted Officer and is working as a head of office in GDCs and also working as DDO/CDDO, under whom there are many section officers (Office Superintendents) but the Grade pay is Rs. 4600/- (Level 7) only.

7. In view of the above, it is requested to kindly clarify whether Establishment & Accounts Officers in Survey of India, who are Gazetted Group 'B' Officers, are eligible to draw the Newspaper reimbursement @ Rs. 500/- per month as per Sl. No. 4 of Ministry of Finance's O.M. No. 25(12)/E.Coord-2018 dated 03.04.2018. It is also submitted that with the implementation of VIIth Central Pay Commission, there is no system of Grade Pay for checking the equivalency.
