- ii. In addition to this office order, instructions enumerated in this office order No. 10/37-G-20 dated 25/4/2011 shall be followed.
- iii. In absence of I/C or Section Officer next senior most officer will look after the Wing/ Section.
- iv. For backlog work at the time of issue of this order, I/C shall be responsible for its completion.


