
3. The following documents were placed before the Placement Committee:-


- a. List of officers due for transfer who have completed tenure (3 years and above) as on 31 Dec 2017 has been uploaded on website of SOI.


4. The recommendations of the committee for transfer/posting of the officers are hereby submitted on Appendix for consideration/approval of the Surveyor General of India.







