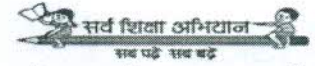

SUB: PROMOTION TO THE POST OF ADDITIONAL SURVEYOR GENERAL IN SURVEY OF INDIA.


