3. In case of any vigilance case/disciplinary proceedings or pendency of punishment against above official noticed at your end, the promotion orders may not be implemented.

4. On promotion, the individual would be required to exercise an option under FR 22 (1)(a)(i) for fixation of pay in the new scale and if the above mentioned officer has got the benefit of FR 22(1)(a)(i) under the MACP Scheme then his pay may be fixed as per prescribed rules.

5. The above mentioned officer will be on probation for two years from the date of his promotion. The Work Assessment of above officer during the period of probation may be sent to this office.

6. The promotion of the officer will be subject to outcome of CWP No.20237/2009 filed by Shri T M Poonja & Others and CWP No. 7683/2010 filed by UOI & others in the Hon'ble High Court of Punjab & Haryana and also subject to further orders that may be passed by the Hon'ble Supreme Court of India in Jarnail Singh batch of cases which is pending in the Supreme Court [SLP C No.30621 of 2011].
