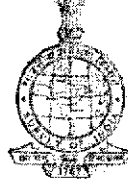

2. The above mentioned officers may assume the charge on promotion. Necessary certificate of assumption of charge on form 0.115 (Acc) may please be sent to this office, in triplicate, for further necessary action.
3. The date of accepting the promotion or the date of refusing promotion, as the case may be, may please be intimated to this office by 13-05-2017 positively. It may be made clear to the officers concerned that in case of their refusal of promotion, no fresh offer of promotion will be made to them for a period of one year from 13-04-2017 in terms of para 17.12 of DoP&T's O.M.No.22011/5/ 86.Estt. (D) dated 10-04-1989 and they will lose seniority vis-a-vis his juniors promoted to the higher grade.
4. In case of any vigilance case/disciplinary proceedings or pendency of punishment against the above officials is noticed at your end, the promotion orders may not be implemented.
5. On promotion, the individual would be required to exercise an option under FR 22(1)(a)(i) for fixation of his pay in the new scale. This is to be made only by the officers who are not holding the post of SS (Adhoc).
