

Notification

G.S.R...... In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Survey of India, Group 'C' Ministerial posts Recruitment Rules, 2006, in respect of the post of Office Superintendent and Assistant, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Office Superintendent in Survey of India under Department of Science and Technology, Ministry of Science and Technology, namely:-

- **1. Short title and commencement.** (1) These rules may be called the Survey of India, Office Superintendent Recruitment Rules, 2023.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- **2. Initial Constitution.-** The incumbents to the post of Office Superintendent holding the post on regular basis, on the date of commencement of these rules, shall be deemed to have been appointed to the post as mentioned in the first column of the Schedule under these rules. These incumbents shall also include those who were holding the post of Assistant prior to its merger with the post of Office Superintendent.
- **3. Number of posts, classification, level in pay matrix.** The number of post, its classification and the level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- **4. Method of recruitment, age-limit and other qualifications, etc.** The method of recruitment, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the Schedule annexed to these rules.
- 5. Disqualification. No person, -
- (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied, that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of this rule.

- **6. Power to relax.** Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- **7. Saving.** Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the other Backward Classes, the Ex-servicemen and the other special categories of persons, in

accordance with the orders issued by the Central Government from time to time in this regard.

Note 2: For the purpose of computing minimum qualifying service for promotion, the service (4) Assistant Surveyor rendered on a regular basis by an officer prior to (4) 1st January 2016 or the date from which the General, revised pay structure based on the 7th CPC India recommendations has been extended, shall be rendered deemed to be service in corresponding pay / pay matrix extended based on the recommendations of the Pay Commission.

Deputation (Including short term contract):

Officer of the Central Government or State Government or Union territory Administration or Autonomous or Statutory Organization or Public Sector Undertaking or recognized University or Institute:

- (a)(i) Holding analogous post on a regular basis in the parent cadre or department, OR
- (ii) with six years regular service in Level-5 (Rs. 29200-92300) of the pay matrix or equivalent in the parent cadre or department, OR
- (iii) with ten years regular service in Level-4 (Rs. 25500-81100) of the pay matrix or equivalent in the parent cadre or department,

AND

- (b) possessing the following educational qualification and experience:
- (i) Bachelors degree from a recognized University or Institute; and
- (ii) At least two years experience in administrative or establishment work.
- **Note 1:** The departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- **Note 2:** Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the

same or some other Organization or Department of the Central Government shall ordinarily not exceed three years.

The maximum age limit for appointment by deputation shall be 'Not exceeding 56 years' as on the closing date of receipt of applications.

Note 3: For the purpose of appointment on deputation / absorption basis, the service rendered on a regular basis by an officer prior to 1st January, 2016 (the date from which the revised pay structure based on the Seventh Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay / pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay / pay scale and where this benefit will extend only for the post(s) for which that grade pay / pay scale is the normal replacement grade without any up-gradation.
